SCHOOL STREETS VARIOUS LOCATIONS - PHASE 3

PROHIBITION OF ALL MOTOR VEHICLES

Leeds City Council in exercise of the powers contained in Sections 1, 2, 9 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act") and of all other powers so enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act and with those persons and organisations specified in the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996 hereby makes the following Order:-

1. For the purposes of this Order –

“**motor vehicle**” shall have the same meaning as in Section 136 of the 1984 Act.

“**Blue Badge**” means any badge issued, or having effect as if issued, under any regulations for the time being in force under section 21 of the Chronically Sick and Disabled Persons Act 1970;

PROHIBITION OF MOTOR VEHICLES

2. No person shall cause or permit any motor vehicle proceeding in the lengths of roads specified in Column 1 of the First Schedule to this Order between the points specified in relation to that road in Column 2 of the said First Schedule during the days and times specified in Column 3 of the said First Schedule.

GENERAL

3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the 1984 Act or by or under any other enactment

4. For the avoidance of doubt any reference in this Order to a length of road shall be deemed to be a reference to more than one length of road where the context requires it

7. This Order is made on the 7 day of September 2023 and shall come into force on the 18 day of September 2023 and shall be cited as the "Leeds City Council (Traffic Regulation) (Movement Restrictions) (No.14) Order 2023"
